> This session will provide an overview and introduction to the roles and responsibilities of historic preservation commissions in NH. Attendees will learn about the enabling legislation that establishes preservation commissions and the differences between a historic district commission vs. a heritage commission and their roles in land use management at the municipal level. The session will cover the basics of what a preservation ordinance should contain, as well as rules of procedure, and other mechanics of a historic district commission. Take aways from the session will be general preservation best practices, an introduction to the Secretary of the Interior's Standards for the Treatment of Historic Properties, and other useful tools for historic district commissions to be effective at their role in preserving their community's heritage while keeping their community vital and viable.

### 10:30 - 11:45 АМ **INFILL DEVELOPMENT AND DESIGN GUIDELEINES** Chris Skelly, Principal, Skelly Preservation Services

Where should we put a new building? How about in the historic district! New infill development in our historic downtowns, village centers and neighborhoods offers many benefits, such as a sustainable development pattern, economic development, additional housing, increased property taxes, and less dependence on automobiles. Yet, concerns over new development in historic districts are common and for good reason. The impacts of incompatible new construction can have long lasting consequences. During this session, attendees will gain an understanding of how infill development can provide new vitality and enrich the setting of a historic district. By reviewing the concepts and philosophies of infill, attendees will learn what to watch out for and what works best in historic areas. For those serving on a local historic district commission, this session will explain the importance of including infill within your design guidelines. For anyone concerned about new development, a takeaway from this session will be understanding the basic tools you need to make sure infill development is a benefit to your historic community.
