Subject: Request for Approval of FY2027 Endowment Fund Disbursement

Pursuant to [NH RSA 227-M:12](#) and [162-C:8](#), the NH Land & Community Heritage Investment Program requests approval from the Council to withdraw up to \$321,871 from the Community Conservation Endowment (CCE) fund for the purpose of awarding stewardship grants for the 2026 monitoring year, and supporting LCHIP's stewardship program administration in fiscal year 2027.

Pursuant to RSA 227-M:12, the CCE *"shall be used by the authority to enforce all grant obligations and to support monitoring by state agencies, local municipalities, and qualifying nonprofit corporations of property subject to grant obligations entered into under this chapter. Such monitoring shall be to ensure that the resources protected through the program will be managed according to the grant obligation"*.

2026 Stewardship Grants

The LCHIP Board of Directors has approved Stewardship Grant awards to 175 stewarding entities to support monitoring of LCHIP-funded properties in 2026, subject to Council approval and steward's submission of qualifying reports. A full list of the properties eligible to receive 2026 Stewardship Grants is attached.

2025 Stewardship Program Administration

The LCHIP Board of Directors seeks \$109,671 to offset expenses incurred in enforcing grant obligations, overseeing annual monitoring, and carrying out intake and cyclical field visits to both historic and conservation properties under LCHIP's long-term stewardship.

Community Conservation Endowment fund

As of June 30, 2026, the CCE held a market value of \$9,100,453. The requested disbursement represents 3.53% of the funds' market value. The FY26 end of year report is attached.

REQUESTED ACTION: Approve disbursement of up to **\$321,871** to LCHIP, comprising up to \$212,200 for the purpose of awarding 2026 Stewardship Grants and \$109,671 for the purpose of supporting administration expenses for LCHIP's stewardship program.
